Agreement for the granting of usage rights to journal articles^{1*}

1.

For the publication of my contribution accepted by the publishers (including abstracts) in the journal **JoSch - Journal für Schreibwissenschaft** and in the journal portal (wbv-journals.de), I hereby give wbv Media GmbH & Co. KG, auf dem Esch 4, Bielefeld, Germany, - hereafter referred to as “publisher” - the right, unlimited in terms of space and time, for duplication and dissemination as well as the non-physical public or individual transmission and reproduction of the contribution in the context of this journal, for all print and volume issues (eg floppy disk, CD-ROM, DVD-ROM) as well as for online use in and from storage media, in particular databases (including electronic storage, making available to the public for individual retrieval, screen rendering and printing by the user, also by way of the Internet). This includes related image templates, plans, maps, sketches, and tables. The publisher is obliged to publish the contribution within a reasonable period of time.

2.

Furthermore, I hereby grant the publisher the rights, unlimited in terms of space and time, for reprints, abstracts (also in foreign language versions and as a preprint), special editions relating to this journal, photomechanical duplications including remote copies, microcopy, microfiche and microform issues as well as picture and sound recordings including audio cassettes and audio CDs. I expressly grant the publisher the unlimited right, in terms of space and time, to publish and use the article in the context of wbv journals. The decision on a fee or free provision of the contribution is the responsibility of the publisher.

3.

The publisher is authorized to conclude usage agreements with third parties with regard to the rights according to Nos. 1 and 2. If any of these rights can be exercised by a collecting society, I hereby authorize the publisher to conclude corresponding contracts with the respective collecting society.

4.

The rights under Nos. 1 and 2 are granted as exclusive rights for a period of two years from the publication of my contribution, and subsequently as a single right. After the two-year period has elapsed, I may assign simple rights of use to the article to third parties, whereby I will make sure by contract that the first publication will be mentioned in the internet portal or, if applicable, in the magazine as a source.

I hereby declare that I have the copyright to my contribution in accordance with Nos. 1 and 2, including related images, plans, maps, sketches and tables. Rights of third parties are not violated by the contribution.

6.

At the time of publication of my contribution I will receive a copy free of charge. The intention of the publication of the contribution is to disseminate its content as widely as possible. In relation to this, it is hereby expressly stated that no payment will be agreed between the contracting parties.

7.

In the same way as the publisher, in the event of a dispute arising out of or relating to this contract and before a legal action is brought before an ordinary court or arbitration tribunal, I shall undertake to seek arbitration according to the provisions for settling commercial disputes made by the Mediation Office of the Chamber of Commerce Ostwestfalen in Bielefeld.
